Internet Safety: What You Don't Know Can Hurt Your Child (From the Office of the Texas Attorney General)

Instructions

The proliferation of child predators using the Internet to target young victims has become a national crisis. A study shows one in seven children will be solicited for sex online in the next year. Texas Attorney General Greg Abbott is urging all parents and teachers to realize the risks our children face online, and do something to stop the predators before they target the innocence of more Texas children. The Texas Attorney General's office is a national leader in tracking down and arresting online child predators. The Cyber Crimes Unit, launched by Abbott in May 2003, has arrested more than 90 predators who used Internet chat rooms to set up what they thought would be a sexual rendezvous with a young girl.

This training session requires you to (1) read a brochure on Cyber Safety; (2) view an internet safety video for parents (16 minutes); (3) view a second short video (5 minutes); and (4) answer a 10-question quiz.

1. Before viewing the video, print the quiz included in this packet so you can answer the questions as you read the brochure and watch the video. (An answer key is included at the end of these materials, so you can check your responses.)
2. Go to <http://www.oag.state.tx.us/internet/cybersafety.shtml> and, under the **first** box entitled "**Cyber Safety**," click on the link to and then read the Cyber Safety **brochure**.
3. Next, click on the link under the **third** box entitled "**Internet Safety for Parents**" and watch the 16 minute video.
4. Then, click on the link under the **last** box entitled "**Internet Chase Video**" and watch the 5-minute video.
5. Print and complete the training certificate included in this packet and return it (along with your quiz, if required by your parish) to your Safety Officer.
